The WPATH standards of care are not an NHS Scotland standard and there is no relationship between NHS Scotland and WPATH. The standards of care document is an internationally developed collaborative document that is one of the resources referred to by gender services across the UK 4 nations, but it does not represent the standard for care in NHS Scotland.

The draft document with the link that has caused concern was a document listed as one submitted by an external organisation as part of a public consultation by the WPATH. The document does not form part of the current standards of care document, nor is it referenced by WPATH in the development of the revised standards which have yet to be published.
