## Please could you provide information on which cloud-based telephony suppliers feature on health board approved frameworks and could you provide a link to the list?

We have now completed the search of our records and can provide you with the following information:

Under Section 17 of the Freedom of Information Act, 2002 (FOISA) an organisation does not have to provide that information if it does not hold it. NHS National Services Scotland (NSS) does not hold this information as NSS have no such framework for internal use.

NSS currently use 8x8 UK Ltd as a Cloud based telephony solution. This was awarded via a G-Cloud agreement during the Covid-19 pandemic. G-Cloud is managed by the UK Government - Crown Commercial Services and has thousands of suppliers. There is a Scottish Government Dynamic Purchasing System (DPS) for Telephony and Communication services which is open to be used by all Scottish Public sector bodies.
